SENECO TAX – \$12,000+ Tax Time Giveaway

Terms and Conditions

1. Promoter

The promoter is Seneco Tax Pty Ltd (ABN 57 685 266 540), trading as ITP Karratha, ITP South Hedland, and ITP West Perth (“the Promoter”).

This promotion is operated solely by **Seneco Tax Pty Ltd** and is not associated with **Seneco Wealth**, **Seneco Finance**, or any other related entities.

2. Promotion Period

The promotion commences at **9:00 AM AWST on 1 July 2026** and ends at **11:59 PM AWST on 30 September 2026** (“Promotion Period”). Final draw will occur on **Monday, 5 October 2026**.

3. Eligibility Criteria

3.1 Entry is open to Australian residents aged 18 years or over who:

- a) Lodge and fully pay for an individual tax return with the Promoter at one of the participating locations (Karratha, South Hedland, or West Perth) during the Promotion Period; and
- b) Provide accurate contact details for prize notification.

3.2 Employees, contractors and immediate family members of the Promoter are ineligible to enter.

4. Entry Conditions

4.1 One entry is automatically granted per individual tax return lodged and paid in full at a participating location.

4.2 Maximum of one entry per individual per location, per tax return.

4.3 All valid entries are retained in the draw pool for the entire Promotion Period (i.e. earlier entries remain eligible for subsequent weekly draws).

4.4 This promotion is not valid in conjunction with any other offer or discount provided by the Promoter.

5. Draw Details

5.1 Draws will be conducted **weekly, every Monday**, starting **Monday, 20 July 2026**, and concluding **Monday, 5 October 2026**.

5.2 Each draw will randomly select (2) winners from all participating offices (i.e. Karratha, South Hedland, West Perth), totalling **two (2) winners per draw week**.

5.3 Draws will be conducted at Unit 13/1329 Hay St, West Perth WA 6005, using a randomised method, under the supervision of a representative of the Promoter, either in person or via approved digital means.

6. Prize Pool

6.1 The total prize pool includes a **minimum value of \$12,000**, comprised of:

- **\$5,000 cash grand prize**, drawn in the final draw on **5 October 2026**
- **A minimum of \$7,000 in tax return refund prizes**, awarded through weekly draws

6.2 Tax return refund prizes will equal the full amount paid by the winner for their tax return service during the Promotion Period.

6.3 The refund prize pool is **uncapped**, and may exceed \$7,000 depending on the value of combined tax return/s of the weekly winners

6.4 Each winner may receive **only one refund prize**, even if they have multiple entries.

7. Winner Notification and Prize Delivery

7.1 Winners will be notified via email and/or phone within two (2) business days of each weekly draw.

7.2 Refund prizes will be issued by **electronic funds transfer (EFT)** within 30 business days of prize confirmation, upon verification of payment records.

7.3 The grand prize winner will be publicly announced on the Promoter's website and/or social media channels on **Wednesday, 7 October 2026**.

8. General Conditions

8.1 The Promoter reserves the right to verify the validity of entries and to disqualify any entrant who tampers with the entry process or acts in breach of these Terms and Conditions.

8.2 If a prize is unclaimed after 14 days of notification, the Promoter reserves the right to redraw the prize from the eligible entry pool.

8.3 Prizes are non-transferable and not redeemable for cash unless otherwise stated.
